#### Campaign Updates

Secretary/Treasurer Palmiscno updated the Board on the Veterans Memorial Park, Rydell Skatepark, Giving Hearts Day, and the Police Memorial to be located at Optimist Park.

#### 2019 Annual Report

Community Relations & Marketing Manager Nelson updated the Board on the 2019 Annual Report that will be mailed to all donors.

### **Operational Review**

Nelson reviewed the activities and events from October 2018 through April 2019, which included the Thanksgiving mailer, pledge reminders, Giving Hearts Day mailer, and other Foundation marketing plans. Nelson also updated the Board on the action plan for the coming months of May 2019 through September 2019.

#### **Update Foundation Bylaws**

Superintendent of Finance Hellyer reviewed the changes to the bylaws. The only major change was to section 2.02 which removed the term limits for Park District Commissioners appointed to the Foundation Board. The Park District Executive Director was also removed from being an ex-officio member of the Foundation Board. Formatting and spelling changes were also made.

#### 2019 Endowment Distributions

Hellyer reviewed the endowment funds. The distribution policy allows for a maximum distribution of 4% using a three-year average. Staff is recommending approval of distributions of \$2,500 from the Sanny and Jerry Ryan Youth Scholarship Endowment, \$722.71 from the Riedlinger Endowment (dependent upon request amounts), \$586.80 from the Jeff Pettit Memorial Endowment (dependent upon request amounts), and \$100 from the Pinky Kraft Memorial Endowment.

Director Panzer made a motion to approve the 2019 endowment distributions as requested. Director Skarperud seconded the motion; the vote was unanimous, motion carried. Vice-President Dvorak and Director LaDouceur were absent.

#### 2018 Audit Report

Hellyer reviewed the 2018 Audit Report, which is audited along with the Grand Forks Park District financial information.

Director Skarperud made a motion to approve the 2018 Audit Report. Director Panzer seconded the motion; the vote was unanimous, motion carried. Vice-President Dvorak and Director LaDouceur were absent.

#### 2018 IRS Form 990

Hellyer reviewed the 2018 IRS Form 990.

Director Panzer made a motion to approve the 2018 IRS Form 990. Director Skarperud seconded the motion; the vote was unanimous, motion carried. Vice-President Dvorak and Director LaDouceur were absent.

#### FINANCIAL REPORT

Hellyer reviewed the March 2019 financial reports. Vendor payments from January 1, 2019, to March 31, 2019, were \$135,342.44.
