# 2023 Annual Report

Director of Operations & Community Relations Nelson updated the Board on the 2023 Annual Report. A draft of the Annual Report was presented and is expected to go to print in the next few weeks and be mailed to Foundation donors. The Annual Report will also be available on the Foundation website. Discussion took place on the inclusion of a summary of the year-to-date activities for the current fiscal year in the Annual Report.

## Campaign Updates

Executive Director Hellyer updated the Board on the current campaigns taking place. Hellyer reviewed past campaigns and provided an overview of funds, spending, and project progress for current campaigns. Renovations and updates at Eagles/Blue Line Club Arena and Kraft Memorial Field are among the top priorities, as well as completion of the Northern Valley Law Enforcement Memorial. Nelson updated the Board on the dedication ceremony at the Northern Valley Law Enforcement Memorial which will take place on May 18<sup>th</sup>.

## 2023 Endowment Distributions

Hellyer reviewed the activity of the endowment funds for the year ended December 31, 2022. The distribution policy allows for a maximum distribution of 4%, using a three-year average. Staff is recommending the Board approve

distributions as follows: Sanny and Jerry Ryan Youth Scholarship Fund in the amount of \$7,500, Riedlinger Fund in the amount of \$826.23, and Pettit Fund in the amount of \$1,197.03. Due to the balance in the fund, no distributions were recommended from the Pinky Kraft Memorial Fund.

Director Skarperud made a motion to approve the 2023 Endowment Distributions as presented. Vice-President Bartholomew seconded the motion; the vote was unanimous, motion carried. Director LaDouceur was absent.

### 2022 IRS Form 990
