INJURY PROCEDURES

NO MEDICAL ATTENTION BEING SOUGHT:

1. Apply basic first aid if necessary.
2. **Notify your supervisor immediately.**
3. **Park District's Incident/Near Miss Report* needs to be completed and turned into supervisor.**
4. **Notify Hannah/Office by next business day morning to complete forms needed.** WSI **"Incident Report"** must be filed "on-line" by 5:00 p.m. the next business day. [Please note: You now have up to 14 calendar days of the date of injury to seek medical attention and file a "First Report of Injury". WSI will still pay the \$250.00 medical assessment fee because an incident report was filed].

EMERGENCIES AND INJURIES REQUIRING MEDICAL ATTENTION:

1. Go to nearest hospital if injury is an emergency or seek proper medical attention with Park District's Designated Medical Provider (DMP). Notify care provider this is a worker's comp injury.
2. If treated at the emergency room, follow-up treatment must be with the Park District's DMP.
3. Medical attention must be provided by the Park District's DMP unless opting out prior to injury.
4. **Notify your supervisor immediately.**
5. **Park District's Incident/Near Miss Report* needs to be completed and turned into supervisor.**
6. **Notify Hannah/Office by next business day morning to complete forms needed.** WSI **"First Report of Injury"** must be filed "on-line" by 5:00 p.m. the next business day.
7. **Workability report must be turned into Hannah/Office from treating doctor before returning to work.**

DESIGNATED MEDICAL PROVIDER (DMP)

We are participating in the North Dakota (WSI) Work Force Safety & Insurance's Risk Management Program. This allows us to designate health care providers to treat your workplace injuries and illnesses. **WSI may not pay for medical treatment** to another provider unless; 1) this is emergency treatment, 2) you are referred by the Park District's DMP, or 3) you **notify us in writing prior to an injury** that you want to be treated by a different medical provider. If there is no individual provider on file, employee must be treated by the Park District's DMP for the first 30 days before requesting to treat elsewhere. *The Park District has the right to require an evaluation through its DMP at any time.*
